When I went into private practice, I continued criminal defense work and started civil rights work. About half of my criminal defense practice is representing indigent defendants in federal court. Almost all of my civil cases are in federal court.

When I was a public defender my typical client was an indigent person. In

private practice, I represent individuals charged with state and federal crimes and those who have been the victim of a civil rights violation and/or a state or federal tort.

All of my practice is litigation. I appear in court frequently. I normally have multiple court appearances each week. From 2019 to present, I have represented Mr. Murphy (personal representative of the estate) in a wrongful death case against New Mexico's Children Youth and Family Department (CYFD). CYFD had taken a two-year-old child (A.G.J.) from his mother and placed him in foster care. A.G.J.'s mother had a severe drug addiction, and her parental rights had been terminated for all of her children. A.G.J.'s step-grandfather, who had fostered another child, was in the process of becoming certified to foster A.G.J. as well.

CYFD knowingly placed A.G.J. back in his mother's custody, despite the fact that she was still using drugs heavily and associating with other drug addicts. There was no evidence that A.G.J.'s mother had a safe home for the defenseless child. While at this mother's home, A.G.J. was murdered by his mother's friend.

A.G.J.'s estate has sued CFYD. The case is currently in discovery.

4. New Mexico v. Castro, Case No. D-307-CR-2009-00562, Third Judicial District Court, Dona Ana County (Judge Conrad Perea); rev'd, 2016-NMCA-085, 381 P.3d 694, rev'd, 2017-NMSC-027, 402 P.3d 688.

From 2013 to present, I have represented Mr. Castro on direct and collateral appeal after he was convicted at trial of a sex offense. His trial attorney continued the case for several years without his client's consent. At trial, it became clear that Mr. Castro's attorney did not investigate or prepare for the case. At one point during expert testimony, Mr. Castro's lawyer left the courtroom. Mr. Castro's lawyer did little to defend his client: he failed to object to improper evidence; failed to impeach the prosecutor's witnesses; and did not make argument to the jury. Mr. Castro's lawyer told the trial judge he did not have enough time to try the case because he was busy the next day, and Mr. Castro's lawyer strongly insinuated to the jury that his client had in fact committed this crime.

I briefed and argued all of the direct and collateral appeals. This case was appealed first to the New Mexico Supreme Court on the defense lawyer's many continuances, which created speedy trial issues. The New Mexico Court of Appeals granted Mr. Castro's appeal on speedy trial issues. However, the New Mexico Supreme Court ruled against Mr. Castro. The trial court then granted Mr.

Castro's petition or a writ of habeas corpus to vacate his conviction based on his lawyer's misconduct at trial.

6. Landau and Landau v. Las Cruces Public Schools, D-307-CV-2014-01923, Third Judicial District Court, Dona Ana County (Judge Douglas R. Driggers)

9. New Mexico v. Le Mier, Case No. D-0911-CR-2012-00075, Ninth Judicial District Court, Curry County (Judge Donna Mowrer). Published Opinion: 2017-NMSC-017, 394 P.3d 959.

From 2013 to 2014, I represented Defendant Le Mier. She was charged with smuggling contraband (her anti-depression medication and other things) into a detention facility. As trial counsel for Defendant, I attempted repeatedly to obtain the names and addresses of the prosecution's witnesses so that I could investigate the case. In 2013, Ms. Antillion was charged in federal court with trafficking heroin. She was a very young woman who had become severely addicted to heroin. Drug traffickers exploited her addiction, abused her, and used her to transport drugs across the United States-Mexico border.

I was able to secure Ms. Antillion's release from jail while the case was pending. I worked with her and United States Pretrial Services to get her drug treatment that she desperately needed. She struggled with her addiction, but she was able to overcome it while the case was pending.

In the end I was able to secure Ms. Antillion a sentence that involved no more jail time, and instead ensured she would continue to get drug treatment and mental health treatment.

I am a litigation attorney, but most of my cases do not result in a trial. I have defended hundreds of criminal cases, resulting in either a dismissal or a plea. I have brought dozens of civil cases that resulted in settlement at mediation.

When I was a state public defender, my caseload was consistently over one hundred cases. Managing this caseload required discipline and organization. I kept a consistent routine that allowed me to meet with clients, attend court hearings, investigate cases, meet with the prosecution and interview their witnesses, conduct legal research, draft motions, and try cases both as first chair and as second chair, when another public defender had a trial. I also handled a large probation violation docket, which required tremendous organizational skills. In New Mexico, probation violations must be resolved or tried to the bench in a very short amount of time. In addition to meeting these deadlines as required by the court, most clients facing probation violations desired to have their case resolved expeditiously. Other than litigation, my time at the public

defender office was dedicated to moving a large caseload in an efficient manner.

When I left the public defender's office, my case load was reduced, and the nature of my cases changed. I began to do grand jury practice, administrative hearings for license revocations, habeas and direct appeals, and plaintiffs' cases, which were mostly in the area of civil rights, and federal court practice.

I have never been a lobbyist. However, since 2018 I have been chair of the New Mexico Criminal Defense Lawyers Association's legislative committee. As chair, I have helped advocate for criminal justice reform, reducing the use of solitary confinement in our prisons and jails, and passing a New Mexico civil rights bill. I have also consistently participated in our local district court's annual free legal clinic, where community members can seek legal advice without charge.

I have taken several small pro-bono civil cases while in private practice.
