Since June 15, 2015, I have served as a United States Magistrate Judge on the United States District Court for the Middle District of Florida. I was selected for that position following a two-stage process. In the first stage, members of a merit selection panel comprised of lawyers and non-lawyers chose five finalists. In the second stage, the United States District Judges of the Middle District of Florida made the final selection from the five finalists. On March 10, 2023, I was reappointed to a second, eight-year term.

The United States District Court for the Middle District of Florida is an Article III court of limited jurisdiction and the jurisdiction of United States Magistrate Judges is governed by 28 U.S.C. §§ 631–639. I manage a docket of pending cases and preside over both civil and criminal matters. I enter orders ruling on non-dispositive motions and enter orders recommending the disposition of dispositive motions. I also preside over all phases of civil cases, including civil jury and non-jury trials when the parties have consented to the magistrate judge's exercise of jurisdiction. I conduct initial appearances, arraignments, bail and detention hearings, preliminary hearings, and competency hearings in criminal cases. I am responsible for the review and authorization of search warrants and arrest warrants while on criminal duty. I also preside over settlement conferences, central violation bureau citation proceedings, and naturalization ceremonies.

A grand jury indicted defendant for possessing a firearm as a felon in violation of 18 U.S.C. § 922(g)(1). The charges resulted after law enforcement performed a traffic stop of defendant's vehicle and located a firearm, ammunition, and marijuana inside the vehicle. Defendant moved to suppress the evidence contending that law enforcement lacked probable cause for the traffic stop and the warrantless search of her vehicle violated the Fourth Amendment. I entered a report and recommendation recommending denial of the motion, finding law enforcement had probable cause to perform the traffic stop after they witnessed defendant's traffic violation. The charges resulted from law enforcement's audio and video surveillance of defendants and information provided by a confidential source. Law enforcement detained defendants and a K-9 alerted to Defendant Rodriguez's vehicle indicating that the vehicle contained narcotics. Law enforcement searched defendant's vehicle and located seven kilograms of cocaine. Defendants moved to suppress the evidence seized after they were detained. I entered a report and recommendation recommending the denial of the motion, finding that law enforcement had reasonable suspicion to detain defendants and the positive alert from the K-9 supplied probable cause to search the vehicle pursuant to the automobile exception to the Fourth Amendment's warrant requirement.
