Early in my career, I served as counsel, and then senior counsel, to Representative Zoe Lofgren. When Representative Lofgren became chair of the House Judiciary Committee's immigration subcommittee in January 2007, I became the subcommittee's majority chief counsel. In that role, I provided legal analysis, advised on policy matters, and supported the Chairwoman with developing and moving legislation through the House and carrying out her immigration oversight agenda.

In June 2014, I became chief counsel for U.S. Citizenship and Immigration Services, the agency that administers the legal immigration system. I led an office of 270 attorneys around the country, provided legal opinions to senior leadership, and supported Department of Justice attorneys in litigation involving USCIS. As chief counsel, I worked closely with the DHS Office of the General Counsel and my counterparts at Immigration and Customs Enforcement, Customs and Border Protection, and other agencies. I remained chief counsel of USCIS until January 20, 2017.

In August 2020, I joined the Potomac Law Group as counsel.

In September 2020, I accepted the opportunity to join the Biden-Harris Transition and consequently discontinued my work with the Potomac Law Group in November 2020.

As chief counsel of USCIS, my client was the agency. I led the attorneys of the Office of the Chief Counsel in providing legal advice internally in matters involving immigration law, human resources, privacy, contracts, and other civil and administrative issues.

I have not appeared in court with the exception of a single appearance in federal court for the defendant, the United States of America, in *Texas v. United States*, 14-cv-254 (S.D. Tex.).

As chief counsel of USCIS, I worked with Department of Justice attorneys, who formally represent all agencies in federal court. However, on June 23, 2015, I joined DOJ attorneys in a hearing before Judge Andrew Hanen in the Southern District of Texas as an attorney for defendants (United States of America) in *Texas v. United States*, 14-cv-254 (S.D. Tex.) (filed December 3, 2014). In the hearing transcript, I was listed as "also present" and was not otherwise in the record.

Other significant cases involving USCIS during my tenure as chief counsel included *Arpaio v. Obama*, 14-cv-1966 (D.D.C.) (filed November 20, 2014); *Mendez Rojas v. Kelly*, 16-cv-1024 (W.D. WA.) (filed June 30, 2016); and *Rosario v. USCIS*, 15-cv-813 (W.D. WA) (filed May 22, 2015).

As chief counsel of USCIS from 2014-2017, I led an office of 270 attorneys around the country in providing legal advice to the agency. My office provided counsel on policies and programs, changes in statute or regulation, and complex and novel legal issues.

As the director of DHS Watch, I provided a briefing and had phone calls with Congressional staff regarding the 2020 financial crisis at USCIS. I occasionally provided information to educate Congressional staff on new USCIS policies affecting its service mission and processing times. I also occasionally joined others to provide background information to Congressional staff on family separation, the Southwest border, detention, and accountability in immigration agencies.

Business Immigration Law, American University Washington College of Law: I taught this course as an adjunct professor in the spring semesters of 2017, 2018, and 2019. The course provided an in-depth review of the laws, regulations, and policies governing the entry of foreign nationals into the United States for employment and business-related purposes. Please see Appendix 17 for copies of the 2018 and 2019 syllabi. I was unable to locate a

copy of the 2017 syllabus, although it would have been similar to the others with some differences to reflect changes in law and policy.

By focusing on immigration law and policy, I have devoted most of my career to public service, often on behalf of underserved communities. I have also worked to advise and encourage the next generation of public servants.

During my years as a congressional staffer, my work regularly focused on underserved communities. For example, I served as staff co-lead for the Congressional Refugee Caucus, where I worked to strengthen protections for people fleeing persecution. Similarly, as staff co-lead for the Vietnam Caucus, I sought to raise attention to the plight of forgotten Amerasians — children born to U.S. military personnel during the Vietnam War. As chief counsel to the immigration subcommittee, I led a team of counsel through an oversight and legislative agenda on the burdens and stress that U.S. military families endure when our immigration laws fail them, on inhumane conditions in immigration detention centers, and on other issues.

I have also frequently mentored high school and college students. For example, in 2019, I worked with America's Voice to bring on a Stanford Gardner Fellow. I volunteered to supervise and coach her during her year-long fellowship to help further her goals in public service. In the summer of 2020, I volunteered to mentor and supervise a high school intern interested in possibly pursuing a career in immigration.

As an adjunct professor, I regularly met with students in my immigration law course to help them begin to chart their career paths.

During law school, I volunteered as a supervisor for the El Centro Legal Aid Tenant/Landlord Clinic in California. I organized fellow law students to participate in immigration law clinics around Los Angeles and co-founded UCLA's Immigration Law Society. Today that student organization continues to focus on placing volunteers with free or low-cost legal service providers for the immigrant community.
