Law Student Letter in Support of the Nomination of Judge Ketanji Brown Jackson to the U.S. Supreme Court

We, the undersigned law students, strongly support President Biden's nomination of Judge Ketanji Brown Jackson to the U.S. Supreme Court. Judge Jackson is impeccably qualified and brings an unwavering commitment to the U.S. Constitution and to the rule of law. In contrast to the last three Supreme Court confirmations, we hope the Senate returns to its standard norms and procedures in considering this historic nomination in a timely and respectful manner.

Judge Jackson brings a wide breadth of experience from across the legal profession—as a federal appellate judge, a federal district court judge, a member of the U.S. Sentencing Commission, an attorney in private practice, and notably, as a federal public defender. Judge Jackson would be the first former public defender to serve on our nation's highest court. This experience will equip the Court with a necessary new lens through which to view the inner workings of the criminal justice system. Judge Jackson's extensive experience demonstrates not only her commitment to fairness, impartiality, and equal justice for all, but also her skill as an effective consensus-builder.

As the first Black woman nominated to serve on the Supreme Court, Judge Jackson's elevation will bring a perspective to the Court's deliberations that has never before been included. Judge Jackson's lived experience is a source of judicial strength. The voices of women and people of color, present on the Court only since the 1960s, have had a profound, legitimating, and democratic impact on the dialogue within the Court. Justice Marshall often wrote forcefully about the impact of the Court's rulings on Black Americans, while Justice Ginsburg and Justice O'Connor were instrumental in cases like *Casey* and *Virginia Military Institute* which centered the experiences of women. Justice Sotomayor's writings during the ongoing COVID pandemic lay bare the risk faced by low-income workers across the nation. Diversity—of ideas, of background, of ability, of identity, of belief—is central to the collaborative process of constitutional interpretation.

As students entering a legal field that is more diverse than ever before, we, the undersigned, believe in a judiciary that reflects the diversity of the people living in America. Though threats to our rights remain, and the theft of Justice Scalia's and Justice Ginsburg's seats continues to severely undermine the Court's legitimacy, Judge Jackson's nomination is a step forward in recognizing that the Court has been, and might still be, a place where the unheard go to be heard, the unseen go to be seen, and the downtrodden have their day in court.
