Dear Chairman Durbin and Ranking Member Grassley:

I write to express my support of Magistrate Judge (MJ) Mary Katherine ("Kit") Dimke to be a District Judge for the Eastern District of Washington. I have known MJ Dimke since 2007, when we both began as Assistant United States Attorneys (AUSAs) in the United States Attorney's Office for the Western District of Washington. During the five years we worked together at the U.S. Attorney's Office, MJ Dimke distinguished herself by her acumen, work ethic, and her passion for pursuing justice. In an office of bright young prosecutors, MJ Dimke was a star. She was an effective advocate who prepared her cases meticulously and challenged the law enforcement agents who worked those cases to think critically about the strengths and washiesses of their investigations at every turn. I recall a large and complex health care fraud prosecution that MJ Dimke and I worked on together. Although I had been the lead prosecutor investigating the case and preparing it for over a year, the addition of MJ Dimke to the case completely energized and refocused our prosecution team on the evidence and challenges of the case. MJ Dimke was universally respected in the office as a strong advocate, but also as a prosecutor who would listen with an open mind to the arguments of defense counsel and push back on injustice where it unfairly tilted the playing field.

MJ Dimke and I became good friends during her time at the U.S. Attorney's Office, and our families remain close to this day. That relationship has provided a window into MJ Dimke's professional successes since leaving the Western District of Washington. I have watched with no surprise as she distinguished herself as a top AUSA in the Eastern District of Washington and for the last five years as a United States Magistrate Judge. MJ Dimke brings the same diligence and energy she showed as a young prosecutor to the disputes in her courtroom. In her personal and professional life alike, MJ Dimke treats people – regardless of their background, position, or status – with tremendous respect.

Finally, and fundamentally, MJ Dimke is a thoughtful, generous and compassionate human being. Sadly, we both lost our fathers within a year of each other in 2008-2009 while we were junior AUSAs. During that time, MJ Dimke supported me as a friend and colleague, helping me navigate a difficult time in my life while facing her own loss.

MJ Dimke will make a terrific district court judge. Her energy, intellect and compassion will leave those who appear before her proud and confident in the rule of law in the United States. I recommend her without hesitation.
