Dear Chairman Durbin and Ranking Member Grassley:

We are writing to voice our strong support for the nomination of our former colleague Sarala V. Nagala to the federal district court of Connecticut and to encourage her confirmation. We are a group of partners and former partners at Munger, Tolles & Olson LLP who were familiar with Sarala's work and contributions to the firm when she was a litigation associate at our firm from September 2009 to July 2012.
