Dear Chairman Durbin and Ranking Member Grassley:

Please allow this letter to serve as the highest possible recommendation for Ana C. Reyes for your consideration for the U.S. District Court for the District of Columbia.

This is the kind of letter that one waits a long time to be able to write. Ana is, quite simply, one of the most interesting and impressive alumni in the storied 242-year history of Transylvania University – a history that includes two Vice Presidents and two Chief Justices of the United States.

On a more personal level, Ana is one of the most engaging and accomplished people I have encountered during my twenty-two years in higher education. I believe specifically that she would be an excellent candidate for a seat on the federal bench because of her ability to connect and communicate so creatively and effectively with a wide range of people. Moreover, Ana served actively as a member of Transylvania University's Board of Regents and she has spoken frequently to our students interested in law. She is always willing to assist Transylvania students from Kentucky and she has supported the University financially, enabling Kentucky students like herself to attend college.

Ana is an extremely bright and articulate person with wide interests and the capacities to explore and present those interests in compelling ways. In short, Ana Reyes has all the capabilities necessary to be an outstanding judge and a fine member of the federal bench. I have no doubt that she would be a tremendous asset to the judiciary. I have no reservations whatsoever about recommending her and I believe that she will make her alma mater, the Commonwealth of Kentucky, and the nation as a whole extremely proud.
