Dear Chairman Durbin and Ranking Member Grassley,

We, the undersigned current and former prosecutors and law enforcement officials, write to the Senate Judiciary Committee in full support of President Joe Biden's nomination of Bradley Garcia to be a judge on the D.C. Circuit Court of Appeals.

As prosecutors and law enforcement officials, we recognize the vital role of the United States Courts of Appeals in the American judicial system. Appellate courts are fundamental to the rights, safety, and livelihood of both the American people and institutions. Therefore, we do not take this endorsement lightly.

Brad Garcia is an accomplished, principled, and effective attorney with extensive appellate experience. Mr. Garcia has represented clients in over 50 cases in federal and state appellate courts and has directly argued more than a dozen appeals, including one before the Supreme Court, ten in federal circuit courts, and two before state appeals courts. Prior to joining the Department of Justice as Deputy Assistant Attorney General in the Office of Legal Counsel, a role that requires impressive legal and constitutional acumen, Garcia served as a partner in O'Melveny & Myers LLP's Supreme Court and Appellate Practice Group. Meanwhile, he also served on the Supreme Court and Appellate Advisory Board of the MacArthur Justice Center.
