Some of us are former federal prosecutors who worked closely with Sarala during her tenure in that Office. Twenty of us are criminal defense attorneys who represented individual defendants, witnesses and victims in cases that Sarala investigated, prosecuted or supervised. We have all had the opportunity to observe first-hand Sarala's integrity, intellect and excellent judgment. Throughout her career, she has consistently demonstrated herself to be a thoughtful, balanced and highly ethical prosecutor who is solely dedicated to the fair and impartial administration of justice. As the Deputy Chief of the Major Crimes Unit, she has supervised the work of other prosecutors and has served in numerous leadership roles in the Office. For many years, she has been the primary contact for particularly sensitive investigations involving trafficking, hate crimes and international matters. She has also played a critical role in the hiring and training of new prosecutors, and received a prestigious national award from the Department of Justice for a complex Romanian computer fraud prosecution.

As a prosecutor, Sarala similarly devoted herself to impactful community outreach and engagement, demonstrating her commitment to all who live in Connecticut. She coordinated the training of over 1,200 police officers in cultural competency, organized "Protecting Your House of Worship" events for religious groups, and educated hundreds of police, social workers, hospital staff, educators and community members about human trafficking. These initiatives, which Sarala often spearheaded single-handedly, were highly effective in improving the reach and impact of law enforcement in the State.

We are confident Sarala will serve with distinction and enthusiastically support her nomination to the U.S. District Court for the District of Connecticut.
