Re: Nomination of Jamal Whitehead to the United States District Court for the Western District of Washington

Dear Chairman Durbin and Ranking Member Grassley:

On behalf of the Washington Employment Lawyers Association (WELA), we write in strong support of Jamal Whitehead's confirmation to the United States District Court for the Western District of Washington. WELA is an organization of over 200 lawyers licensed to practice law in Washington. WELA is a chapter of the National Employment Lawyers Association. WELA advocates in favor of employee rights in recognition that employment with dignity and fairness is fundamental to the quality of life. WELA's board and members believe that Mr. Whitehead is exceptionally well qualified to serve as a United States District Judge.

Mr. Whitehead entered private practice after years in public service, having served as a trial attorney for the Equal Employment Opportunity Commission (EEOC) in the Seattle field office and as an Assistant United States Attorney for the Western District of Washington.
