Dear Chairman Durbin and Ranking Member Grassley:

As her former direct supervisor at O'Neill & Borges, LLC (O&B), I am pleased and honored to recommend, without reservations, Judge Gina R. Méndez-Miró's confirmation to the U.S. District Court for the District of Puerto Rico. I have no doubt that her efforts and litigation skills in that case greatly contributed to accelerate plaintiffs' early decision to withdraw their claims and our ability to get the case dismissed in favor of our client, JAF Communications.

In addition to litigation, on several occasions I entrusted her with drafting employment manuals and internal policies and regulations.
