## LETTER ENDORSING THE CONFIRMATION OF HON. GINA R. MÉNDEZ-MIRÓ AS UNITED STATES DISTRICT COURT JUDGE FOR THE DISTRICT OF PUERTO RICO

Dear Chairman Durbin and Ranking Member Grassley:

As a former Puerto Rico Chief of Staff (2019), Senator at Large (2017-2019), Secretary of the Department of Corrections and Rehabilitation (1997-2000) and practicing attorney, I am proud to endorse Hon. Gina R. Méndez-Miró's nomination for the United States District Court for the District of Puerto Rico. Currently, she serves with notable distinction as an Appeals Court Judge in Puerto Rico. I am motivated by Judge Méndez-Miró's varied professional experience, impeccable trajectory in public service and personal qualities which already make her a distinguished member of the Puerto Rico judiciary.

FTO fully understand her success as a sitting judge, one must review her professional path in the legal field which speaks for itself. Judge Méndez-Miró's career as an attorney originated at O'Neill and Borges, P.S.C., (O&B) one of the most respected and well-known law firms in Puerto Rico. top judges in the Court of Appeals where she has built a reputation as hard working and fair jurist, who invariably issues very well-reasoned and well written opinions.

Based on my experience and first-hand knowledge of Judge Méndez-Miró's strengths and capabilities, I can attest to the value she would add to the federal judiciary both, from a legal and substantive standpoint and personally, as she possesses the highest standard of integrity. Upholding such standard commands my trust, confidence, and respect. Having served as a Senator immediately following Judge Méndez-Miró's Senate tenure, I know that you need a particularly skilled individual to navigate the too often tempestuous waters of a state legislature and rise unscathed from it. Judge Méndez-Miró was able to perform her duties effectively while never compromising her integrity. Judge Méndez-Miró is well regarded and respected by elected officials from the two major parties alike —and their staffs— as a skilled negotiator, a fair and balanced administrator, a brilliant lawyer, and an honest and straightforward communicator. Accordingly, it is not surprising that when she was nominated to serve as an Appeals Court Judge, she obtained the unanimous consent from the Senate.
